## PREFACE

The Mississippi Emergency Management Agency Multi-Year Integrated Preparedness Plan (IPP) serves as a roadmap to meet the intent of the agency’s organizational goal of protecting lives and property by preparing, planning, mitigating, responding, and recovering from disasters and emergencies. The IPP is also a guidance document for scheduled training, exercise, and planning activities to be conducted. The IPP is a living document that is subject to continuous review and revisions. This plan will be updated annually to validate the gaps identified in conducting exercises following after-action reports. This is a three-year integrated preparedness plan that includes the five mission areas of prevention, protection, mitigation, response, and recovery including core capabilities.

To achieve the state’s mission of a safe, secure and sustainable Mississippi, stakeholders provide valuable information to build the multi-year training and exercise focused IPP through completion of the Integrated Preparedness and Planning Workshop (IPPW). The IPP provides the foundation for future collaboration and partnerships in preparing for disaster and mitigating consequences.

## MISSION STATEMENT





## PURPOSE

The purpose of the Multi-year Integrated Preparedness Plan (IPP) is a roadmap to the organization's overall training and exercise program priorities for a specific multi-year time period. It is a living document that can be updated and refined annually. These priorities are linked to corresponding core capabilities, and, if applicable, a rationale based on existing strategic guidance, threat assessments, corrective actions from previous exercises, or other factors. This Multi-year IPP identifies the training and exercises that will help the organization build and sustain the core capabilities needed to address its training and exercise program priorities.

The Multi-year IPP will lay out a combination of progressively building exercises – along with the associated training requirements – which address the priorities identified in the Integrated Preparedness Planning Workshop (IPPW). A progressive, multi-year exercise program enables organizations to participate in a series of increasingly complex exercises, with each successive exercise building upon the previous one until mastery is achieved. Further, by including training requirements in the planning process, organizations can address known shortfalls prior to exercising capabilities.

Included in this Multi-year IPP is a training and exercise schedule, which provides a graphic illustration of the proposed activities scheduled for the years 2023 through 2025. This schedule represents the progression of training and exercises that should take place in accordance with the guidance included in the Homeland Security Exercise and Evaluation Program (HSEEP), using the building-block approach. The 2020 State Preparedness Report (SPR)/Threat Hazard Identification and Risk Assessment (THIRA) was also taken into consideration. This document sets forth those core capabilities where the greatest challenges exist for the State of Mississippi.

The IPP plays an important role in the implementation of the National Preparedness System (NPS) by supporting the building, sustainment, and validation of core capabilities essential to achieving the National Preparedness Goal (NPG) of a secure and resilient nation.

The Integrated Preparedness and Planning Workshop (IPPW) is the annual forum for developing, reviewing, and updating an IPP and schedule. During the IPPW, local and state agencies conduct a needs analysis and identify the trainings and exercises necessary for the next three years. To determine the needs, participants review after action reports (AAR) and the improvement plans developed as a result from exercises or real-world events. The IPPW provides a platform for participants to update their multi-year training and exercise schedule.

## PROGRAM GOALS AND OBJECTIVES

The ongoing goals and objectives for the Mississippi Emergency Management Training & Exercise Integrated Preparedness Program is to develop and maintain a comprehensive all-hazards training and exercise program to evaluate and test all aspects of the emergency management system. This goal is divided into four objectives:

- **Objective 1: Develop and Maintain a Multi-Year Integrated Preparedness Plan**

Develop and maintain a Multi-Year Integrated Preparedness Plan with local, state, public and private sector partners, in accordance with Homeland Security Exercise & Evaluation Program (HSEEP) guidelines, as well as community defined needs. Conduct Integrated Preparedness Planning Workshops (IPPW) for all local emergency managers annually.

- **Objective 2: Coordinate and Facilitating Training to Support Areas of Deficiency**

Coordinate and facilitate training to support areas of deficiency addressed in jurisdictional training needs assessments, as well as provide training to encourage National Incident Management Systems (NIMS) compliance. Provide NIMS/ICS courses based on the whole community needs in order to meet the objectives and identifiable gaps.

- **Objective 3: Establish a Routine Exercise and Improvement Evaluation Program**

Coordinate and facilitate exercises to evaluate the knowledge, skills, and abilities of emergency personnel and support agencies during an emergency. Coordinate and facilitate exercises to validate plans, policies, and procedures of stakeholders. Develop and implement corrective actions addressing the gaps in capabilities to track areas of improvement.

## PROGRAM PRIORITIES

Mississippi Emergency Management Agency priority training goals are to ensure the whole community is trained and prepared for all disasters in the State. The first priority is to ensure that personnel are National Incident Management System (NIMS) compliance. Another priority is to ensure personnel are trained in accordance with the baseline training criteria to support exercises by offering how the organization decided upon its priorities. Ensure stakeholders attend the IPPWs to collect data for training and exercises.

As appropriate, discuss how existing strategy documents (e.g., State/Urban Area Homeland Security Strategy), threat and hazard identification and risk assessments, capabilities assessments, and past After-Action Reports (AARs) and Improvement Plans (IPs) informed the development of the priorities describe each priority.

## **Implement the National Incident management System (NIMS) and the National Response Framework (NRF)**

State and local agencies will continue to implement the NIMS and the NRF. As required under HSPD-5, personnel are being trained in NIMS / ICS and Emergency Operations Plans (EOPs) and Standard Operating Procedures (SOPs) are being updated to align with the NRF. Regional exercises will assess the level of understanding and utilization of NIMS and NRF procedures. Enhance the abilities of local, state, and tribal to prevent, protect, prepare for, respond to, and recover from all-hazards. Jurisdictions and the State of Mississippi have plans in place that address multi-disciplinary guidelines, procedures, and standards. Jurisdictions have the training necessary for a multidiscipline response to and recovery from all hazard incidents.

## **Collect data from annual Integrated Preparedness Planning Workshops**

The goal of the annual IPPW is to collect data of training and exercises currently scheduled, as well as necessary or desired future trainings and exercises. During the IPPW, participants identified capability gaps from After Action Reports (AARs) and Improvement Plans (IPs) from both real-world incidents and planned exercises, so that appropriate trainings and exercises could focus on and strengthen those areas of improvements.

The National Preparedness Goal (NPG) identifies 32 distinct activities, called Core Capabilities, which are needed to address our greatest risks. The Core Capabilities serve as both preparedness tools and provide a common language for preparedness activities. A few of the core capabilities were identified in the IPPWs:

During the 2022 IPPW, stakeholders reviewed their organization's After-Action Reports (AARs) from previous exercises, as well as their responses to real world events, and decided certain areas which to focus future trainings and exercises. From the identified areas of improvement, IPPW participants cross walked their needs to specific Core Capabilities, so that the Integrated Preparedness Planning Workshop (IPPW) would have a strategic foundation to build upon.

## METHODOLOGY AND TRACKING

Integrated Preparedness Planning Workshop (IPPW's) were conducted with a regional concept during the months of April through June 2022. From the IPPW's capability gaps were identified from local emergency managers in the State of Mississippi. The training courses and exercises selected were deemed most appropriate to assist in strengthening the program priority capabilities for the State of Mississippi. For each key area addressed, the planning group decided upon a cycle, mix and range of training courses/activities and exercises that will allow the organization to increase its preparedness through a deliberate and progressive training and exercise approach. The results of the training activities and implementation of the corrective action recommendations resulting from exercises will be monitored to ensure a consistent approach to continually improve planning, training, and exercising cycle to guarantee full development of each priority and capability.

The progressive approach should:

- Challenge participants with increasingly advanced coursework and scenarios.
- Incorporate, reinforce, and verify lessons learned;
- Identify demonstrated capabilities and areas in need of improvement;
- Provide a means of evaluation and corrective action for exercises; and
- Ensure a method to share lessons learned and best practices from training courses and exercises.

Mississippi Emergency Management Agency (MEMA) provides training and exercises to improve disaster preparedness and validate plans to prevent, mitigate, respond to, and recover from threats and hazards that may pose a risk to individuals and property.

### **2022 Integrated Preparedness Planning Workshop Schedule**

The 2022 IPPW was held virtually. All local emergency managers and other stakeholders were sent an invitation to attend the workshop between the months of January-March 2022.

# PLANS, THREATS/HAZARDS AND RISK ASSESSMENTS DATA, AND ASSESSMENTS

## **Plans**

All State and Local plans are written, revised, or updated to coordinate efforts to ensure that training is offered on all plans that are developed, and exercises are conducted to test the plans.

## **Threats/Hazards and Risk Assessment Data**

The Threat and Hazard Identification and Risk Assessment (THIRA) is submitted by the State to FEMA on an annual basis, in accordance with federal requirements. The THIRA is a risk assessment tool that helps evaluate the impacts of a hazard – including natural, human-caused, and technological hazards – on the State’s ability to perform its core capabilities before, during, and following a disaster. Additionally, the THIRA helps to identify what activities need to be sustained, and what resources (i.e., plans, organization, equipment, training and exercises) are necessary to sustaining said activities to ensure the continued performance of core capabilities. The information that emerges from this process, which involves interviewing State agencies to identify their ability to perform their capabilities and what they need in order to do so, can be used to support decision making, including related to identifying needed training and exercises.

## **Assessments**

The Office of Preparedness seeks to align training and exercise priorities with corresponding State priorities. These priorities emerge based on the vision and priorities of senior leadership, as well as needs identified through participation in exercises and real-world events, as captured in After Action Reports and Improvement Plans (AAR/IPs), which are implemented and tracked to validate corrective actions.

## TRAINING

Mississippi Emergency Management Agency uses a systems approach to training adopting a blend from the National Incident Management System (NIMS) Training Program and instructional system design principles that build effective training in five phases: Analyzing, Designing, Developing, Implementing, and Evaluating (ADDIE).

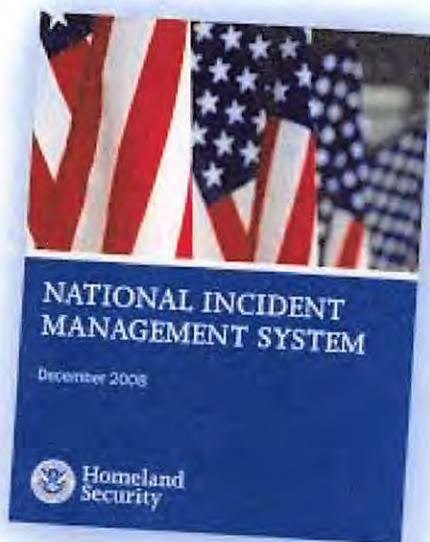
The NIMS Training Program is a critical component of a comprehensive training program, which requires a continuous cycle of planning, equipping, training, exercising, evaluating, and correcting. The ADDIE model allows the Emergency Managers to determine instructional needs and priorities, develop solutions, implement those solutions, and assess training effectiveness.

The information contained in this phase is based on and derived from accepted adult learning theories and current instructional development practices. Although adherent to these models, Mississippi Emergency



Management Agency is not restricted to them as some training goals may be better addressed through a different model.

Training records related to NIMS, ICS, and the EOC are collected, maintained, and preserved by the Agency for 5-years.



## EXERCISE

Mississippi Emergency Management Agency abides by Homeland Security Exercise and Evaluation Program (HSEEP) principles in its approach to exercises and evaluations. HSEEP provides a common approach to exercise program management, design and development, conduct, evaluation, and improvement planning. HSEEP allows for the development, execution, and evaluation of exercises that address the priorities established in this plan.



**Homeland Security Exercise and Evaluation Program (HSEEP):** The HSEEP doctrine consists of fundamental principles that frame a common approach to exercises. It is intended to enhance consistency in

exercise conduct and evaluation while ensuring exercises remain a flexible, accessible way to improve preparedness across the nation. HSEEP uses a common methodology for planning and conducting individual exercises. This methodology applies to exercises in support of all national preparedness mission areas. A common methodology ensures a consistent and interoperable approach to exercise design and development, conduct, evaluation, and improvement planning, as depicted in the figure above. The State of Mississippi has adopted the Homeland Security Exercise and Evaluation Program.

The four phases of the HSEEP cycle include Design and Development, Conduct, Evaluation, and Improvement Planning; each of which is described below:

**Design and Development.** In designing and developing individual exercises, exercise planning team members are identified to schedule planning meetings, identify and develop exercise objectives, design the scenario, create documentation, plan exercise conduct and evaluation, and coordinate logistics.

**Conduct.** After design and development activities are complete, the exercise is ready to occur. Activities essential to conducting individual exercises include preparing for exercise play, managing exercise play, and conducting immediate exercise wrap-up activities.

**Evaluation.** Evaluation is the cornerstone of an exercise and must be considered throughout all phases of the exercise planning cycle, beginning when the exercise planning team meets to establish objectives and initiate exercise design. Effective evaluation assesses performance against exercise objectives, and identifies and documents strengths and areas for improvement relative to core capabilities.

**Improvement Planning.** During improvement planning, the corrective actions identified during individual exercises are tracked to completion, ensuring that exercises yield tangible preparedness improvements. An effective Corrective Action Program (CAP) develops IPs that are dynamic documents, which are continually monitored and implemented as part of the larger system of improving preparedness. ## **HSEEP Fundamental Principles**

**The following principles frame the common approach to HSEEP:**

- Guided by senior leaders
- Informed by risk
- Capability-based, objective-driven
- Progressive exercise planning approach
- Common methodology
- Whole Community integration

## **Program Management**

**Integrated Preparedness Cycle:** A continuous process of planning, organizing/equipping, training, exercising, and evaluating/improving that ensures the regular examination of ever-changing threats, hazards,

and risks. Preparedness priorities are developed to ensure that the needed preparedness elements are incorporated through this continual and reliable approach to achieve whole community preparedness.

**Integrated Preparedness Planning Workshop:** A meeting that establishes the strategy and structure for an exercise program and preparedness efforts while setting the foundation for the planning, conduct and evaluation of individual exercises.

**Integrated Preparedness Plan:** A document for combining efforts across components of the Integrated Preparedness Cycle to make sure that a jurisdiction/ organization has the capabilities to handle threats and hazards. The IPP allows for a more deliberate approach to multi-year preparedness activity planning.

## EXERCISE TYPES

### Discussion-Based Exercises

Discussion-based exercises are normally used as a starting point in the building-block approach to the cycle, mix, and range of exercises. Discussion-based exercises include seminars, workshops, Tabletop Exercises (TTXs), and games. These types of exercises typically highlight existing plans, policies, Mutual Aid Agreements (MAAs), and procedures. Thus, they are exceptional tools for familiarizing agencies and personnel with current or expected jurisdictional capabilities. Discussion-based exercises typically focus on strategic, policy-oriented issues; operations-based exercises focus more on tactical response-related issues. Facilitators and/or presenters usually lead the discussion, keeping participants on track while meeting the objectives of the exercise.

#### Seminars

Seminars are generally used to orient participants to, or provide an overview of, authorities, strategies, plans, policies, procedures, protocols, response resources, or concepts and ideas. Seminars provide a good starting point for jurisdictions that are developing or making major changes to their plans and procedures. They offer the following attributes:

- Informal discussions led by a seminar leader
- Lack of time constraints caused by real-time portrayal of events
- Low-stress environment employing a number of instruction techniques such as lectures, multi-media presentations, panel discussions, case study discussions, expert testimony, and decision support tools
- Proven effectiveness with both small and large groups.

#### Workshops

Workshops represent the second tier of exercises in the HSEEP building block approach. Although similar to seminars, workshops differ in two important aspects: participant interaction is increased, and the focus is on achieving or building a product (such as a plan or a policy). Workshops provide an ideal forum for the following:

- Building teams
- Collecting or sharing information
- Obtaining consensus
- Obtaining new or different perspectives
- Problem-solving complex issues
- Testing new ideas, processes, or procedures
- Training groups in coordinated activities

In conjunction with exercise development, workshops are most useful in achieving specific aspects of exercise design such as the following:

- Determining evaluation

elements and standards of performance • Determining program or exercise objectives • Developing exercise scenario and key events listings A workshop may be used to produce new standard operating procedures (SOPs), Emergency Operations Plans (EOPs), MAAs, Multi-Year Exercise Plans, and IPs. To be effective, workshops must be highly focused on a specific issue, and the desired outcome or goal must be clearly defined.

Potentially relevant topics and goals are numerous, but all workshops share the following common attributes:

- Effective with both small and large groups
- Facilitated, working breakout sessions
- Goals oriented toward an identifiable product
- Information conveyed employing different instructional techniques
- Lack of time constraint from real-time portrayal of events
- Low-stress environment
- No-fault forum
- Plenary discussions led by a workshop leader

### **Tabletop Exercises (TTX)**

TTXs involve senior staff, elected or appointed officials, or other key personnel in an informal setting, discussing simulated situations. This type of exercise is intended to stimulate discussion of various issues regarding a hypothetical situation. It can be used to assess plans, policies, and procedures or to assess types of systems needed to guide the prevention of, response to, and recovery from a defined incident. TTXs are typically aimed at facilitating understanding of concepts, identifying strengths and shortfalls, and/or achieving a change in attitude. Participants are encouraged to discuss issues in depth and develop decisions through slow-paced problem solving rather than the rapid, spontaneous decision-making that occurs under actual or simulated emergency conditions. In contrast to the scale and cost of operations-based exercises and games, TTXs can be a cost-effective tool when used in conjunction with more complex exercises. The effectiveness of a TTX is derived from the energetic involvement of participants and their assessment of recommended revisions to current policies, procedures, and plans.

TTX methods are divided into two categories: basic and advanced. In a basic TTX, the scene set by the scenario materials remains constant. It describes an event or emergency incident and brings discussion participants up to the simulated present time. Players apply their knowledge and skills to a list of problems presented the facilitator, problems are discussed as a group, and resolution is generally agreed on and summarized by the leader. In an advanced TTX, play focuses on delivery of pre-scripted messages to players that alter the original scenario. The exercise facilitator usually introduces problems one at a time in the form of a written message, simulated telephone call, videotape, or other means. Participants discuss the issues raised by the problem, using appropriate plans and procedures. TTX attributes may include the following:

- Achieving limited or specific objectives
- Assessing interagency coordination
- Conducting a specific case study
- Examining personnel contingencies

- Familiarizing senior officials with a situation
- Participating in information sharing
- Practicing group problem-solving
- Testing group message interpretation

## **Operations-Based Exercises**

Operations-based exercises represent the next iteration of the exercise cycle; they are used to validate the plans, policies, agreements, and procedures solidified in discussion-based exercises. Operations-based exercises include drills, Functional Exercises (FEs), and Full Scale Exercises (FSEs). They can clarify roles and responsibilities, identify gaps in resources needed to implement plans and procedures, and improve individual and team performance. Operations-based exercises are characterized by actual response, mobilization of apparatus and resources, and commitment of personnel, usually over an extended period of time.

### **Drills**

A drill is a coordinated, supervised activity usually used to test a single specific operation or function in a single agency. Drills are commonly used to provide training on new equipment, develop or test new policies or procedures, or practice and maintain current skills. Typical attributes include the following:

- A narrow focus, measured against established standards
- Instant feedback
- Performance in isolation
- Realistic environment

### **Functional Exercises (FEs)**

The FE, also known as a command post exercise (CPX), is designed to test and evaluate individual capabilities, multiple functions or activities within a function, or interdependent groups of functions. FEs are generally focused on exercising the plans, policies, procedures, and staffs of the direction and control nodes of the Incident Command System (ICS) and Unified Command (UC). Generally, incidents are projected through an exercise scenario with event updates that drive activity at the management level. Movement of personnel and equipment is simulated.

The objective of the FE is to execute specific plans and procedures and apply established policies, plans, and procedures under crisis conditions, within or by particular function teams. An FE simulates the reality of operations in a functional area by presenting complex and realistic problems that require rapid and effective responses by trained personnel in a highly stressful environment. Attributes of an FE include the following:

- Evaluating Emergency Operations Centers (EOC), headquarters, and staff
- Evaluating functions
- Examining inter-jurisdictional relationships
- Measuring resource adequacy
- Reinforcing established policies and procedures

## Full-Scale Exercises (FSE)

The FSE is the most complex step in the exercise cycle. FSEs are multi-agency, multi-jurisdictional exercises that test many facets of emergency response and recovery. They include many first responders operating under the ICS or UC to effectively and efficiently respond to, and recover from, an incident. An FSE focuses on implementing and analyzing the plans, policies, and procedures developed in discussion-based exercises and honed in previous, smaller, operations-based exercises. The events are projected through a scripted exercise scenario with built-in flexibility to allow updates to drive activity. It is conducted in a real-time, stressful environment that closely mirrors a real incident. First responders and resources are mobilized and deployed to the scene where they conduct their actions as if a real incident had occurred (with minor exceptions).

The FSE simulates the reality of operations in multiple functional areas by presenting complex and realistic problems requiring critical thinking, rapid problem solving, and effective responses by trained personnel in a highly stressful environment. Other entities that are not involved in the exercise, but that would be involved in an actual incident, should be instructed not to respond. An FSE provides an opportunity to execute plans, procedures, and MAAs in response to a simulated live incident in a highly stressful environment. Typical FSE attributes include the following:

- Activating personnel and equipment
- Allocating resources and personnel
- Analyzing memorandums of understanding (MOUs), SOPs, plans, policies, and procedures
- Assessing equipment capabilities
- Assessing inter-jurisdictional cooperation
- Assessing organizational and individual performance
- Demonstrating interagency cooperation
- Exercising public information systems
- Testing communications systems and procedures

## NATIONAL TRAINING AND EDUCATION DIVISION (NTED)

**Training Resources:** Courses available through the Consortium partners as well as courses offered by training partners can be assessed through FEMA's national Training and Educational Division (NTED).

The National Incident Management System (**NIMS**) Training Program: The National Incident Management System (NIMS) Training Program defines the national NIMS training program. It specifies National Integration Center and stakeholder responsibilities and activities for developing, maintaining, and sustaining NIMS training. student attendance. The Mississippi Emergency Management Agency T&E Program utilizes the NIMS Training Program in recommending and providing training to emergency managers and the whole community. Independent Study/Online-Based: The FEMA Emergency Management Institute (**EMI**) offers a variety of Independent Study (IS) courses that support the priorities listed in this plan and general emergency management function. These courses are aimed at providing awareness level training and serve as required

prerequisites for several management or performance level instructor lead classes. These courses can be found at: <http://training.fema.gov/IS/crslist.aspx>.

National Training and Education Division (NTED) delivers training to qualified participants in three delivery modes: Resident: At the training provider's own facility; Mobile: At or near the location of the agency that requests the training; and Online: This self-paced training is delivered in an asynchronous format via computer and internet connection. NTED provides tailored training to enhance the capacity of state and local jurisdictions to prepare for, prevent, deter, respond to, and recover safely and effectively from potential manmade and natural catastrophic events, including terrorism. To date, NTED has delivered training and broadcast information to over 2 million first responders. NTED draws upon a diverse group of training providers, also referred to as training partners, to develop and deliver NTED approved training courses. Besides the National Domestic Preparedness Consortium (NDPC) and the Rural Domestic Preparedness Consortium (RDPC), other providers include:

- National Domestic Preparedness Consortium (**NDPC**), which is a professional alliance, sponsored through the Department of Homeland Security (DHS), FEMA National Preparedness Directorate. The NDPC provides classroom, online and mobile delivery courses at no cost to the responder, jurisdiction, or agency. Each of these organizations are national experts in various disciplines, including chemicals, explosives, radiological/nuclear devices, bioterrorism, counter-terrorism, agro-terrorism, and emergency management systems. NDPC reflects the missions of all these organizations with its commitment to provide quality, cost-effective counter-terrorism training to the nation's emergency responders. The Mississippi Emergency Management Agency Preparedness office will assist jurisdictions in identifying courses that may resolve their unmet training needs. The State Training Officer advises, assists, and processes applications for individuals to attend classroom training at various consortium schools as well as coordinating mobile deliveries requested by local jurisdictions. Classroom deliveries are offered year around. Mobile deliveries require a minimum of 60 days to set up and coordinate with the state training point of contact and typically have minimum attendance requirements to ensure conduct. - Center for Domestic Preparedness (**CDP**) in Anniston, Alabama: Resident training of prevention, deterrence and response to chemical, biological, and nuclear attacks involving hazmat. Noble Healthcare Facility offers hands on training for a variety of health focused classes. CDP offers several law enforcement specific classes to include CBRNE Response, successfully mitigate threat incidents involving civil disorder, knowledge and skills regarding the tools and information necessary to extricate individuals safely from protester devices. **New Mexico Institute of Mining and Technology (New Mexico Tech):** The Energetic Materials Research and Testing Center (EMRTC) at New Mexico Tech (NMT) is the consortium's lead partner for explosives, live explosives, and incendiary devices training. Courses are delivered directly and resident.

Louisiana State University's Academy of Counter-Terrorist Education (National Center for Biomedical Research and Training): Mobile training courses dealing with Weapons of Mass Destruction (WMD), counter-terrorism, and high consequence events, for all disciplines including emergency management, law enforcement, HazMat teams, public health, EMS, hospital, agricultural, and others.

**Counter Terrorism Operations Support Program (CTOS):** Located at the U.S. Dept. of Energy's Nevada Test Site, CTOS delivers specialized training related to the detection, response, and mitigation of radiological/nuclear incidents, providing responders with hands-on experience in a controlled radiologically contaminated environment. CTOS is a one-of-a-kind outdoor laboratory and experimental center originally established as the Atomic Energy Commission's on-continent proving ground and has conducted more than four decades of nuclear weapons testing. **National Emergency Response and Rescue Training Center (NERRTC-TEEX)** at Texas Engineering Extension Service: NERRTC prepares state and local officials for the management challenge posed by Weapons of Mass Destruction (WMD) through hands-on, scenario-driven training and computer-based simulations. The Emergency Operations Training Center uses state-of-the-art simulation and computer-based technologies to train first responders and city officials to manage a crisis through a unified command approach with realistic, real-time simulation and training analysis at a command-post level not provided by any other organization.
